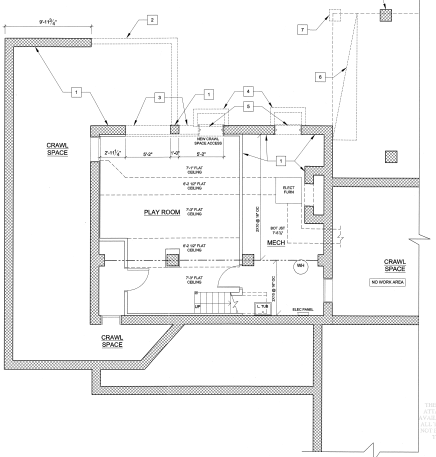


- BSMT PLAN NOTES:**
- 1 EXISTING WALL, DOOR, WINDOW OR OTHER ITEM TO REMAIN
 - 2 FILL IN EXIST WALL OR SCHEDULED WALLS & FINISHES
 - 3 NEW 1/2" CMU FOR WALL
 - 4 NEW 6" SLAB ON GROUND
 - 5 CONCRETE SLAB
 - 6 NEW SURFACE FINISH, SEE SCHEDULE TO DEMOLISH
 - 7 EXIST STAIRWAY TO REMAIN AS-IS
 - 8 EXIST SCREENED PORCH PER TO REMAIN
 - 9 NEW PER AS NEEDED
 - 10 NEW 8" HD FIRM WALL, 2M @ 16" OC
 - 11 INTERMEDIATE CONCRETE WALL @ 16" OC
 - 12 REMOVE SLEEP PLUMP IN WALL TO EXHIBIT

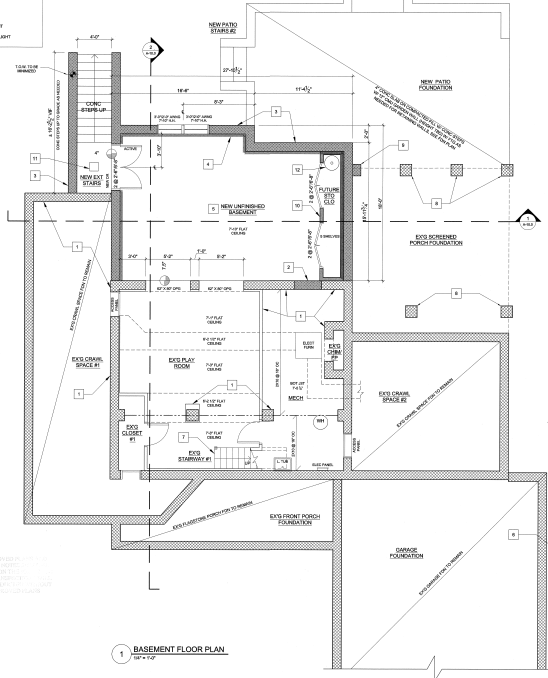
